" This contract contains provision for STALLION/MARE INCAPABLE OF BREEDING. Should the Stallion die, be sold or become unfit for breeding purposes, all advance booking fees, (prior to the mare being bred), will be refunded to Mare Owner, thereby canceling this contract.

Should the mare die, or become unfit to breed, the Mare Owner has the option of breeding another approved mare."

"This contract contains a LIVE FOAL GUARANTEE. A live foal is described as a newly born foal which stands and nurses without assistance. If a foal is born dead there are RETURN BREEDING PRIVILEGES IN 2016, if the Stallion Owner is notified within 24 hours of the birth and receives a Veterinarian's statement confirming the death. In the event the mare is disposed of prior to birth of foal, the Live Foal Guarantee will only be valid if a replacement mare is approved by the Stallion owner in advance of a return breeding. *If the Stallion should die or become unfit for breeding, the Mare Owner has the option of breeding said mare to another Stallion, as offered, or, the Stallion Owner will refund 1/2 ( 50%) of the Breeding Service Fee, as paid.* "

"This contract contains RETURN BREEDING PRIVILEGES. Should the mare fail to conceive, abort, miscarry or produce a stillborn foal, the Mare Owner has the privilege to return said mare for breeding services through July 2015 or in the year 2016 breeding season. An additional one time seasonal booking fee of \$250 will be due, if the mare is returned for breeding in 2016."

" A BREEDERS CERTIFICATE for the relevant Breed Registry Association, will be issued to the Mare Owner after the mare has produced a live foal from this Stallion, and ALL fees as billed by the Kruger Ranch, L.L.C. and/or the attending Veterinarian, are paid in full."

" Stallion Manager may have mare checked by licensed Veterinarian for breeding condition, the cost of which mare owner shall pay. Stallion Owner, Managers and Veterinarians, shall assume no liability for mare that will not breed, cannot conceive, or for accident, sickness or death of mare &/or her foal; but will exercise reasonable effort to settle mare and use good judgment in care and supervision of mare. Mare Owner shall not be responsible for injury or accident to Stallion or Management personnel."

"All fees for artificial insemination &/or Veterinarian work will be billed to the mare owner directly from the servicing Veterinarian. A completed Veterinarian information form must be completed and attached to & considered part of this breeding contract. If there is an outstanding balance due on the mare owner's boarding account, the balance due must be paid as billed or account will be assessed billing penalties. A breeders certificate will not be issued until ALL such fees are paid in full. Mare Owner hereby grants a possessory lien [Idaho Code 45-805 (b)], to the Kruger Ranch, L.L.C., for all unpaid fees."

**CONTRACT PURPOSE** in consideration of a Booking and Breeding Service Fee for the Breeding Season of **2010**,

for the breeding of the mare as identified above; this contract is entered by both the MARE OWNER/BREEDER, and the KRUGER RANCH, LLC. BREEDING STABLE; with the intent that care of said mare (& foal), will be provided for in this contract.

**ACCEPTANCE OF RESPONSIBILITY**

During the time that the mare (& foal) is in the custody of the Stable Management, the Stable Management shall exercise reasonable care to protect mare (& foal) from death, illness, accident, fire and theft. Mare Owner has inspected the Stable premises and/or has in some way been satisfied that the conditions of the premises provide an adequate and reasonable level of safety for said horses(s) and the Mare Owner, and Mare Owner's families, guests and visitors who may enter the premises. The Mare Owner understands that each animal is unique and the Breeding Stable cannot guarantee the safety of the horse(s). Breeding of horses may place above normal stresses on the animals both physically and mentally and the Breeding Stable is in no way responsible for the results of reasonable levels of stress which could potentially cause injury, illness and/or loss of horse(s) by death. The Breeding Stable shall diligently try to settle mare; however, if mare fails to settle for any reason, Mare Owner will hold the Breeding Stable harmless. Breeding Stable agrees to give Mare Owner ample opportunity to settle mare. The Breeding Stable, and any party associated with the Breeding Stable, is not liable for death, sickness and/or accident caused to the mare and/or foal; and the Mare Owner is not liable for death, sickness and/or accident caused to the Stallion by the Mare Owner=s mare.

Any services for Veterinarian, Farrier, transportation, purchases and miscellaneous expenses are additional costs and will be included with the daily mare care costs on the Mare Owners account. All fees must be paid as billed. All overdue accounts will be assessed late penalty. All fees must be paid before mare leaves Stable, unless credit arrangements are made in advance & attached to this contract. Mare Owner hereby grants a possessory lien [Idaho Code 45-805 (b) ], to the KRUGER RANCH, L.L.C. for ALL unpaid fees, due to the KRUGER RANCH, L.L.C.

**EMERGENCY CARE** Should mare (& foal) become sick or injured, Stable Management shall attempt to immediately contact the Mare Owner or Mare Owners regular veterinarian as indicated below:
